WHAT TO BRING?

- **Last year's tax return.**
- **Bank Information for electronic deposit or withdrawal.**
- **Identification:** Photo ID for both spouses, Social Security card (or ITIN) for each individual.
- **Income:** W-2 (wages), 1099-INT (interest), 1099-DV (dividends), SSA-1099 (social security), 1099-R or RRB-1099 (retirement), and 1099-MISC.
- **Expenses:** Unreimbursed medical expenses, receipts for donated items, 1098 mortgage interest statement, bill of sale for vehicles, boats, or major home improvements with taxes.
- **Other:** Health care coverage forms, caregiver information for claiming child care.
